**Coverage Highlights:** Commercial General Liability Policy will pay amounts up to the policy limit that an insured is legally obligated to pay as damages for bodily injury, personal injury or property damage (subject to policy terms and conditions). The property damage or bodily injury must have occurred during an approved pickleball sporting or social activity. The PCO determines what activities/play is covered by the policy. Any approved play such as practices, tournaments and scheduled play is covered. Click here for information on currently approved pickleball sporting and social activities. If you are not sure if a particular practice, tournament, event or scheduled play is covered, please check with PCO.

**Requests for a Certificate of Insurance:** If the facility that you are using to host a PCO approved pickleball sporting or social activity requires "proof of liability" or "additional insured" status please complete the Certificate of Insurance request form here.

**Administration:** If you are served with a summons and complaint, or if you receive a claim for damages from an attorney or third party, you must contact PCO immediately by emailing [president@pickleballcanada.org](mailto:president@pickleballcanada.org) . All incidents that may result in a claim need to be reported to the insurance carrier in a timely manner.

Initial claim must be filed within 60 days from date of injury. All accident medical claims are those in excess of all other valid and collectible insurance plan(s) including provincial health care plans.
