# PROFESSIONAL BACKGROUND:

Thirty years as a dedicated and highly effective member of the Royal Canadian Mounted Police. I have developed strong management and communication skills, both written and oral, through practical application and formal training. Have been repeatedly been recognized in annual evaluations and subsequent promotions for distinguished performance.

#### PROFESSIONAL EXPERIENCE

- First Appearance Prosecutor for Alberta Justice. Dealt with those with Summary Offence tickets prior to trial, looking for a mutual agreement to facts, to stream line the court process.
- Operations Crew Leader for the City of Edmonton. Organize personal, work orders, schedules and physical security of sites.

- One and a half years as the Operations Manager Traffic Safety Programs for a number of smaller Alberta communities. Duties included, but not limited to, managing 21 staff, shift scheduling, budgeting, public complaints, and regular liaising with police of jurisdiction and municipal officials of communities served;
- Eight years experience as a Detachment Commander. Supervised all RCMP personnel, including civilian support staff. Responsible for all administrative functions, including development of emergency and terrorism response plans, programs and training, management of budgets up to \$2.4 million dollars, quality controls, performance evaluations and submission of monthly reports. Reviewed, played a lead role in investigational files, developed numbered sources and provided guidance and feedback to junior officers.
- Intelligence Investigator for the Joint Intelligence Group (JIG) attached to the G8 at Kannanaskis 2002. JIG was comprised of a multiple number of police and government agencies from Canada and the United States. Primary role was to develop sources of information on subversive groups.
- Eight years experience as a senior investigator/team leader recognized an outstanding and tenacious investigator on complex federal investigations (Frauds, Drugs and Proceeds of Crime).
- Three Organized Crime Affidavits (Project KISS) for the legal interception of private communications (Part VI) that went unchallenged in Court. Obtained the first Organized Crime Part VI Affidavit in Canada.
- Four Organized Crime Affidavits (Project KATALYST) for the legal interception of private communications (Part VI) that successfully withstood Court challenges on all aspects by defence counsel.
- Extensive experience in providing Court testimony on serious/complex investigations including wire taps applications, search warrants and production orders.
- Extensive experience in preparation of Criminal Code search warrants (Production Orders) (487 & 487.01) for Commercial Crime, Proceeds of Crime and Organized Crime files. Most search warrants (Production Orders) were in excess of 100 pages in length due to the complexity of the investigations.
- Developed numerous intelligence sources (numbered and other), affidavits, operational plans, requests for Mutual Legal Assistance (MLAT's), Income Tax Affidavits, Management Orders and general reports for evidence gathering and prosecutorial purposes.
- As investigator/project manager for three major projects, supervised entire investigation, including investigators and support staff; provided daily guidance to junior investigators and other subordinates; ensured sufficient controls were in place for management of budgets; prepared monthly submissions to the respective heads of the joint forces team; and liaised with other law enforcement agencies, both domestic and abroad.
- Projects completed have successfully resulted in the dismantling of criminal organizations with seized assets totalling over \$2 million in Edmonton and area.
