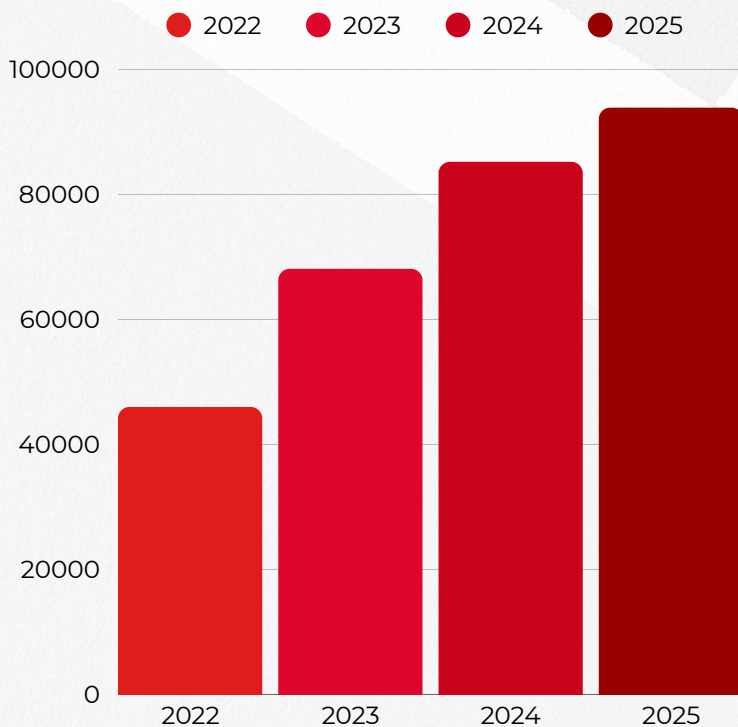

SANCTIONED TOURNAMENT SUBSIDY PROGRAM

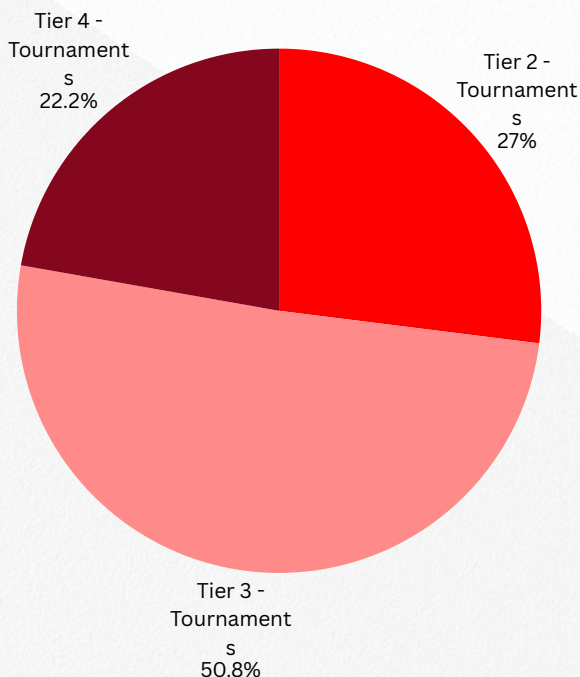
As the national governing body for the sport, Pickleball Canada sanctions tournaments across the country, providing competitive opportunities exclusively for its members. Sanctioning ensures each event meets consistent standards of quality, fairness, and player experience.

In 2025 Pickleball Canada created an initiative to provide a **\$500 subsidy** to all Pickleball Canada sanctioned tournaments, made possible by Pickleball Canada's Corporate Partners. This initiative helped support local pickleball communities while increasing the number of pickleball tournaments nation wide.

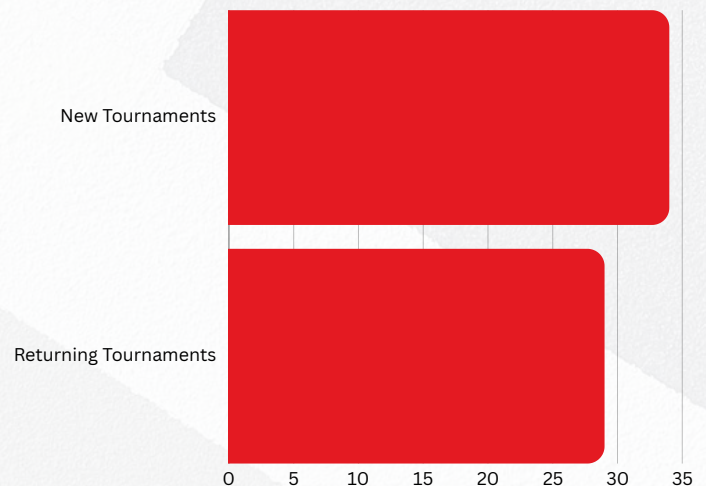
Over **13,300** participants competed across **65** sanctioned events in **2025**.

SANCTIONED TOURNAMENT SUBSIDY PROGRAM

Over the course of 2025 the Tournament Subsidy Program saw approximately **40%** of sanctioned tournaments apply for and receive funding from Pickleball Canada. As a result, more than **\$30,000** was provided to support local events and help strengthen the sport at the grassroots level.

The Sanctioned Tournament Subsidy Program continues to reduce financial barriers, support volunteer organizing committees, and promote greater national consistency in tournament delivery. The program has helped drive an increase in new sanctioned events and strengthened engagement with clubs looking to elevate the quality and standards of their tournaments.



PROVINCIAL TOURNAMENT SUPPORT



In 2025, Pickleball Canada introduced an **\$8,000** tournament subsidy and a **\$2,000** medal subsidy to support Provincial Championships, made possible through the organization's corporate partnerships. This initiative was created to help strengthen the competitive pathway from Provincial Championships to the National Championships. **Ten** provincial events were successfully delivered, including the first-ever Provincial Championships in both **Newfoundland & Labrador** and **Prince Edward Island**. In total, nearly **\$100,000** was provided to PTSOs to support the growth and delivery of their Major Championship events.

SAFE SPORT

SAFE SPORT POLICY SUITE DEVELOPMENT



Pickleball Canada continues to advance its commitment to a safe, respectful, and inclusive environment for all participants. Significant progress has been made toward the development of a comprehensive Safe Sport Policy Suite, designed to align the organization with national standards and best practices across the sport sector.

The suite will establish clear and accessible guidelines for conduct, reporting, and accountability, ensuring that athletes, coaches, officials, & volunteers understand their rights and responsibilities. In addition to outlining expectations for behaviour, the suite will support consistent and effective complaint management processes, helping to ensure concerns are addressed in a timely, fair, and transparent manner.

This work reflects Pickleball Canada's ongoing commitment to safeguarding participant well-being and promoting a positive sport culture. Set for implementation in early 2026, the new Safe Sport Policy Suite will serve as a foundational resource for the entire pickleball community, strengthening education, protection, and support across all levels of the sport.



FACILITY DEVELOPMENT

One of the main barriers to pickleball participation across Canada is the lack of facilities within the pickleball ecosystem. To address this, Pickleball Canada developed a Facilities Task Team in late 2024, made up of Pickleball Canada members who specialized in development projects of facilities in their local community.

This group developed a Facility Guidebook that now serves as a comprehensive resource bringing together practical information, clear guidance, and proven approaches to help users navigate the planning, design, and management of pickleball spaces.

Whether enhancing an existing club, exploring new facility options, or supporting a larger community initiative, this Guidebook provides the insights and best practices needed to make informed decisions. It is designed to support the continued growth of pickleball across Canada and to help ensure facilities meet the needs of players of all ages, abilities, and levels of play.

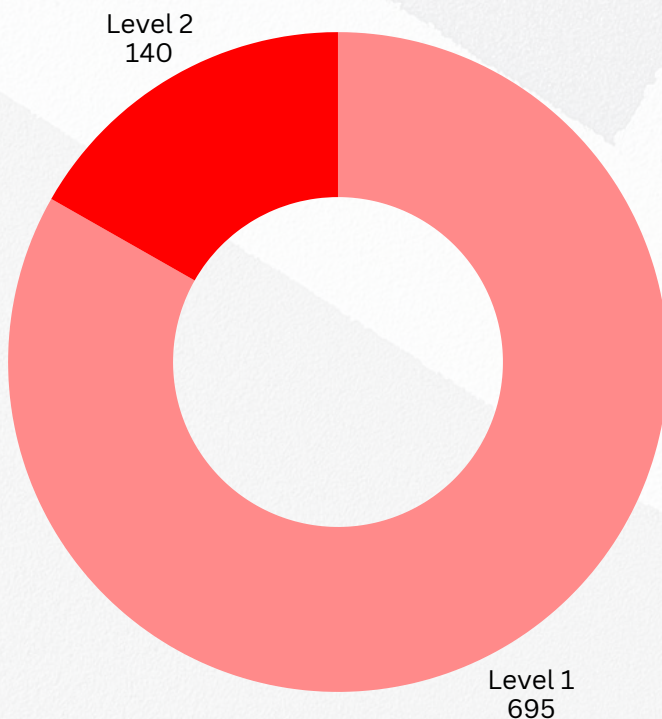
COACH PROGRAM

Pickleball Canada, in partnership with Tennis Canada's Tennis Professionals Association, offers the National Coach Education Program for Pickleball. The program provides educational courses, resources, and professional development for the ambassadors, instructors, coaches, and club managers dedicated to helping players improve their skills. Through the Coaching Association of Canada's National Coaching Certification Program (NCCP), coach education and training is available nationwide, strengthening pickleball communities across all provinces and territories while promoting safe, high-quality coaching standards.

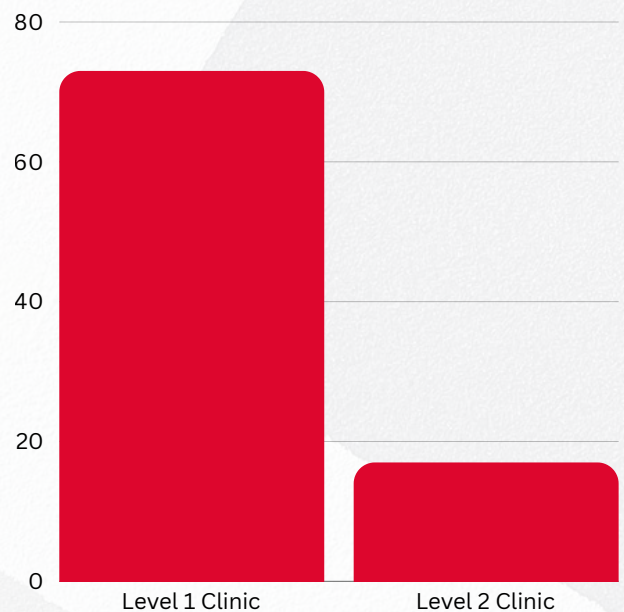

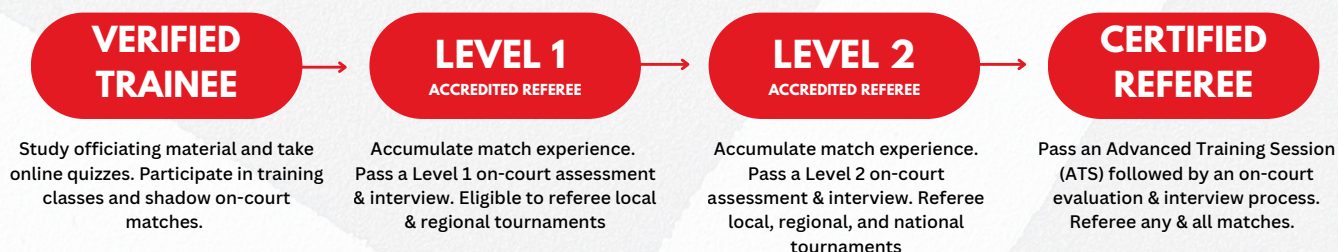


OFFICIATING PROGRAM

The Pickleball Canada Officiating Program outlines the pathway for officials to progress from Trainee to Certified Referee. Delivered in partnership with USA Pickleball, the program provides reciprocal recognition such that referees certified through this process are acknowledged in both countries.

Candidates who begin training in one country and continue in the other must hold active memberships with both Pickleball Canada and USA Pickleball and collaborate with the appropriate Regional Referee Training Coordinators (RTCs) and Regional Certified Referee Coordinators (CRCs) to complete their certification requirements.

Each individual who wishes to become a referee will need to complete the process as indicated above.





OFFICIATING PROGRAM

REFEREE TRAINING COORDINATORS & CERTIFIED REFEREE COORDINATORS

To support referee development, Canada is divided into three regions, each with a Referee Training Coordinator (RTC) and a Certified Referee Coordinator (CRC). While these roles are intended for Certified Referees, Level 2 Referees sometimes serve in these positions while additional Certified Referees are undergoing training nationwide.

The RTC guides new referee candidates through the training program until they achieve their Level 2 credentials. Once candidates reach Level 2, the CRC oversees their continued development and conducts the evaluation process required to become a Certified Referee.

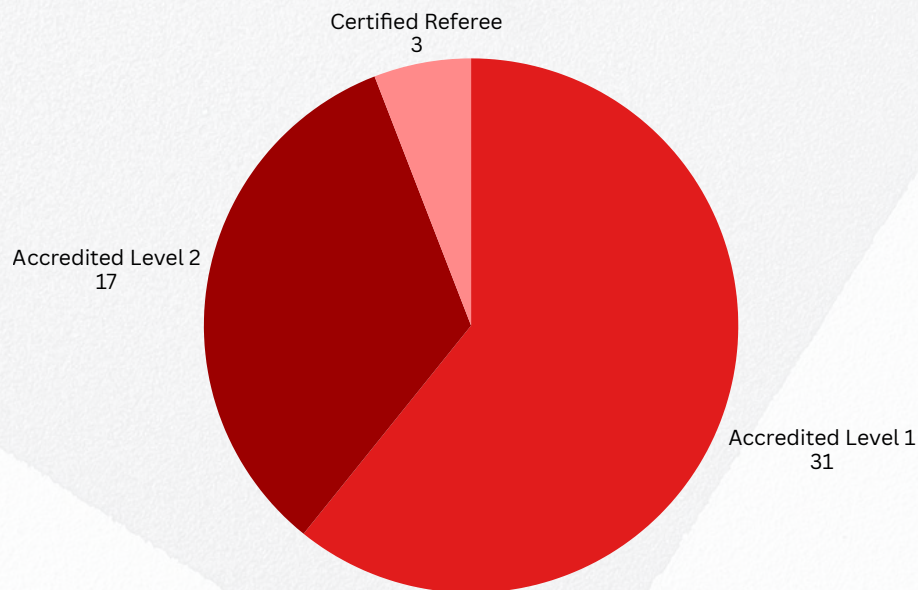

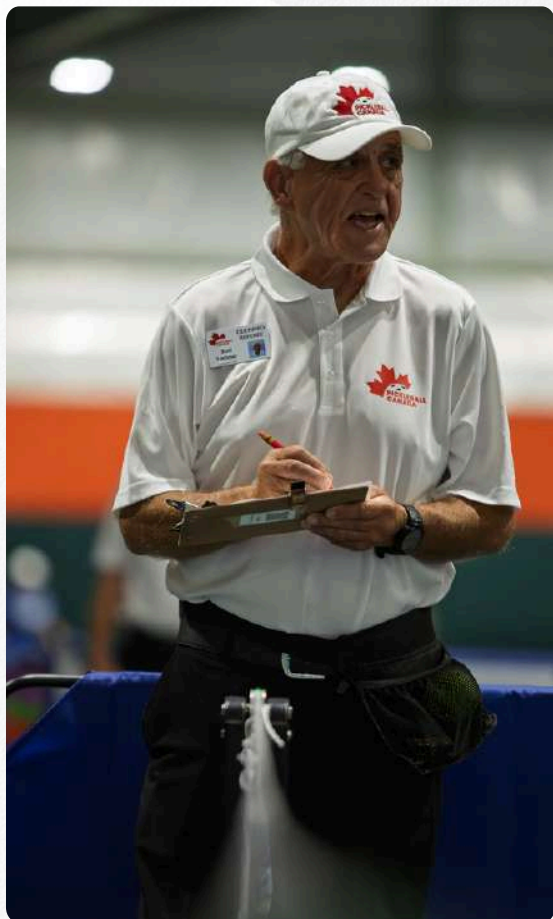


2025 PROGRAM SUMMARY:

VERIFIED TRAINEE PROGRAM:

In **2025**, Pickleball Canada utilized the Verified Trainee program, designed to help individuals interested in becoming referees gain practical, on-court experience. Early training showed that managing the clipboard and scoresheet often demands most of a new referee's attention. Through guided practice, candidates learn to handle scoring tools more efficiently so that their actions do not disrupt the flow or pace of the game. The program helps trainees build confidence and proficiency before progressing to the next stages of referee certification.

Over the course of the year Pickleball Canada received over **90+** applications to get started in the program, and plans are in place to .continue to develop this feature of the Officiating program.



YOUTH PROGRAM



Pickleball Canada is committed to supporting the next generation of players and expanding youth participation nationwide. In partnership with Franklin, Pickleball Canada provided school kits, complete with paddles, pickleballs, and nets to Pickleball BC to help launch the Activating Youth Pickleball in BC initiative. This program introduces pickleball to more than **16** elementary schools and has already engaged over **2,500** students from Kindergarten to Grade 7 across three BC regions. Along with supplying equipment, Pickleball Canada also supported Vancouver teachers in obtaining NCCP pickleball certification to ensure safe and effective instruction. Pickleball Canada continues to collaborate with PTSOs across the country to advance youth program development and grow the sport at the grassroots level.

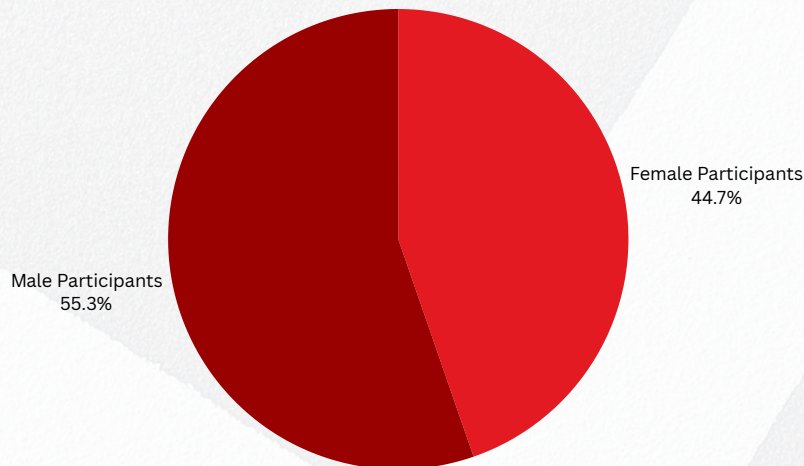
NATIONAL CHAMPIONSHIP

In 2025, Pickleball Canada's National Championship (the 2025 Myoflex® National Championship Presented by HearingLife) was hosted in Winnipeg, Manitoba from **August 19th - August 24th**. Spanning six days, the event welcomed more than **800** participants and over **1,200 spectators** from across the country.

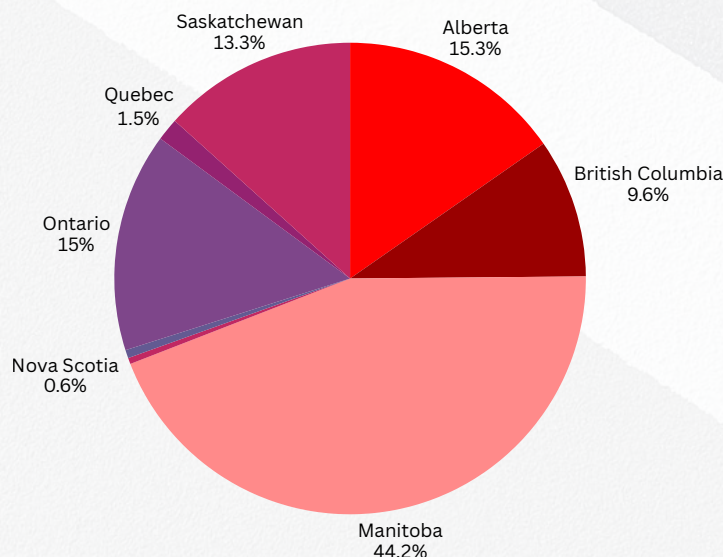
This successful championship was made possible thanks to the outstanding efforts of the Host Committee, Pickleball Manitoba, and a dedicated team of more than **200 volunteers**.

EVENT SUMMARY:

Throughout the **six** days of competition, more than **32 courts** were in use and over **100 events** were played. The championship featured both age-based and skill-based divisions, along with the addition of a Junior Competition and the Provincial Team Championship (PTC).

More than **700 awards** were presented across Men's and Women's Singles, Mixed Doubles, and Men's and Women's Doubles in both age and skill categories.





NATIONAL CHAMPIONSHIP

JUNIOR COMPETITION

During the National Championship, a dedicated Youth Event was held on August 21, featuring **12** young athletes competing in Gender Doubles, Mixed Doubles, and Gender Singles.

The event was very well received by both spectators and participants, offering an exciting new addition to the championship experience. Pickleball Canada hopes to continue including this Youth Event in future National Championships.





NATIONAL CHAMPIONSHIP

PROVINCIAL TEAM COMPETITION

Pickleball Canada proudly introduced the Provincial Team Competition (PTC) at the 2025 Myoflex® National Championship Presented by HearingLife. This inaugural event brought together six provinces—British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, and Quebec—in a friendly yet highly competitive inter-provincial team format that celebrated top talent and provincial pride. The event was held on August 21, 2025.

Each provincial team consisted of **16 to 24** athletes rated **4.0 or higher**, competing in two divisions: Open (all ages) and Masters (50+). Events included Men's Doubles, Women's Doubles, Mixed Doubles, Men's Singles, and Women's Singles, marking an exciting new addition to the National Championship program.

This year, Team British Columbia claimed first place, followed by Team Ontario in second and Team Manitoba in third. [For full results, please visit the link provided.](#)

Based on the enthusiasm and results in Winnipeg, we plan for this event to be a part of all future National Championships.





PICKLEBALL CANADA TECHNOLOGY

The Pickleball Canada National System (PCNS) has served as our state-of-the-art membership and registration platform since 2021. As a three-tiered system supporting Pickleball Canada, PTSOs, and Affiliated Clubs, the PCNS enables members to easily register, renew, and manage their profiles while providing clubs with tools to communicate with their membership, host websites, and organize tournaments and events. The PCNS continues to offer significant benefits to our affiliated clubs and associations, helping streamline operations and support the growth of pickleball across the country.

KEY DEVELOPMENT PIECES OF THE PCNS:

Throughout 2025 the PCNS Work Group, made up of representatives from each province, met quarterly to help guide system improvements. Thanks to their collaboration, several key enhancements were implemented this year, including the resolution of duplicate member issues, adding QR code functionality, improving waitlist features, and introducing branded registration pages for PTSOs.



PICKLEBALL CANADA TECHNOLOGY



UPGRADE REQUEST PROCESS:

Beginning in 2025, Pickleball Canada introduced an Upgrade Request process that allows members to submit system improvement suggestions or report any issues directly through their PCNS dashboard. These requests are reviewed by Pickleball Canada, assessed for feasibility with our developers, and incorporated into future system enhancement plans.

The Upgrade Request form is easily accessible on every member's registration dashboard.

AMBASSADOR PROGRAM

Over the course of 2023–24, Pickleball Canada identified a significant gap in year-round media content and communication, with most member engagement occurring only around national championship events, leaving long periods with limited updates or interaction. At the same time, Pickleball Canada recognized the need to strengthen its relationships with members by providing more consistent, meaningful communication that reflects the sport’s rapid growth and evolution.

There was also a need to better connect Pickleball Canada’s Corporate Partners with our membership through new and engaging content initiatives to enhance value for all stakeholders. These goals highlighted the importance of improving communication efforts to share updates, showcasing progress, and supporting the overall development of the game across the country.



AMBASSADOR PROGRAM

FIRST YEAR RESULTS:



In early 2025, Pickleball Canada launched its Ambassador Program, selecting **17** Ambassadors from more than **150** applicants from across the country. Over its first year, these Ambassadors produced consistent, community-driven content that highlighted local and provincial events, member stories, and Corporate Partner initiatives, resulting in a more than **50%** increase in overall page traffic and a major shift in audience engagement. Instagram became Pickleball Canada's fastest growing platform, surpassing Facebook for the first time, with impressions rising from fewer than **500** per post to a consistent range of **1,000** to **2,000** supported new followers to our social media pages.

The program's initial launch alone generated nearly **7,000** impressions, making it one of the organization's top performing posts. These efforts expanded national awareness of pickleball activities and strengthened member engagement. It also contributed to the growth of sanctioned tournaments, increasing visibility of Pickleball Canada's merchandise store, and enhancing exposure for Corporate Partners.

Pickleball Canada looks to expand this program for 2026 to continue the momentum created around Pickleball Canada's communication initiatives.





DIGITAL ENGAGEMENT

Pickleball Canada aims to ensure its communication efforts effectively highlight the growth of the sport while continuing to attract new audiences through strategic digital communication initiatives.

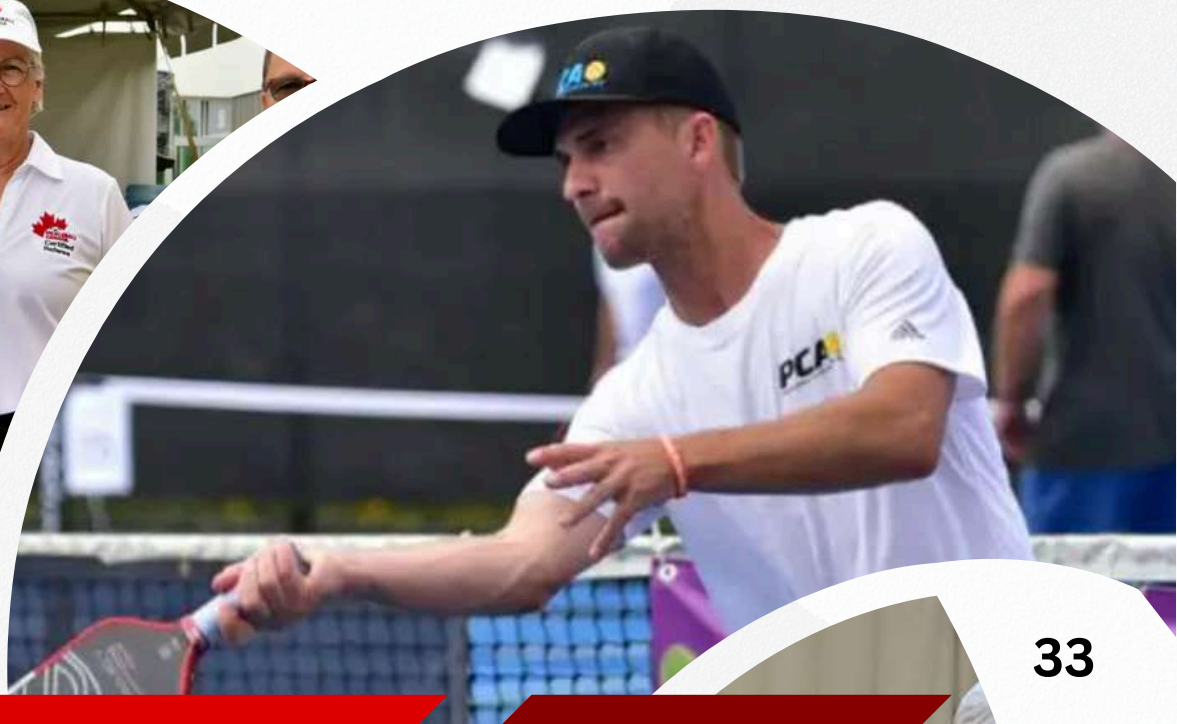
GOVERNANCE & RISK



Pickleball Canada advanced its governance framework this year through the dedicated work of the Risk Management Committee, which began identifying key organizational and operational risks and outlining strategies for future mitigation. This foundational work strengthens informed planning and demonstrates Pickleball Canada's commitment to proactive and transparent risk management.

In addition, the organization continued to modernize its governance practices by progressing toward a fully policy-based board structure. The Governance Committee focused on reviewing and updating bylaws and governance policies to ensure clear roles, effective oversight, and sound decision-making. In parallel, the Policy Committee reviewed priority areas requiring refinement, helping to ensure consistency, clarity, and alignment across the organization.

To support this ongoing modernization, Pickleball Canada also held a Special General Meeting, where several bylaws were updated to strengthen organizational effectiveness and support a more efficient and accountable board structure. Together, these efforts provide a strong governance foundation for the organization's continued growth.





INSURANCE

Pickleball Canada established a comprehensive insurance program where members of Pickleball Canada have access to Sport Accident Insurance during club approved events while playing pickleball.

Pickleball Canada's affiliated clubs have access to General Liability Insurance while operating these club activities, as well as Directors and Officers coverage.

SUMMARY OF 2025 INSURANCE PROGRAM ENHANCEMENTS

Following a comprehensive review of the Pickleball Canada Insurance Program, several improvements were implemented for **2025**, with no increase in member premiums from **2024**. The enhancements to the General Liability Policy included:

- **Tenants Legal Liability** increased from **\$1 million** to **\$5 million**, offering expanded protection for damage to rented or leased facilities.
- **Employers Liability** increased from **\$1 million** to **\$2 million**, providing stronger coverage for employer-related litigation where Worker's Compensation does not apply.
- **Employee Benefits Liability** added to the program for the first time, offering **\$1 million** in coverage for errors in administering employee benefit plans.
- **Abuse and Molestation Liability** increased from **\$500,000** to **\$1 million**, strengthening safeguarding measures across the organization.

These updates collectively enhanced the protection offered to Pickleball Canada members, staff, and affiliated organizations for **2025**.

INSURANCE



ADDITIONAL PROGRAM ENHANCEMENTS

This year, Pickleball Canada expanded its insurance offerings to better support and protect Provincial/Territorial Sport Organizations (PTSOs). Through this enhanced program, PTSOs now have the opportunity to enhance the **Directors & Officers (D&O) Liability Insurance** and **Cyber Security Insurance** included in their coverage.

These optional add-on policies strengthen organizational resilience by safeguarding volunteer leaders, reducing exposure to governance-related risk, and providing protection against emerging cyber threats. This initiative reflects Pickleball Canada's continued commitment to supporting member organizations through sound risk management practices and responsive service offerings.





CORPORATE PARTNERS

Corporate support is a key contributor to the success of Pickleball Canada, and we are extremely grateful for our partners, who work closely with us to build strong relationships that help grow our sport and support our members. These collaborations have enhanced the value of a Pickleball Canada membership, including the provision of exclusive offers and subsidy programs that directly benefit our community.

Each corporate partner contributes to elevating the overall member experience, by enhancing the atmosphere at Pickleball Canada events or providing access to valuable platforms and resources such as DUPR and Pickleball.com. Together, these partnerships help expand opportunities for players and ensure that our members receive meaningful, high-quality support.

Through the backing of our partners, Pickleball Canada was able to invest **\$120k** into community level pickleball events in 2025.

We extend our sincere gratitude to our corporate partners for their continued support, collaboration, and investment in the future of pickleball in Canada.

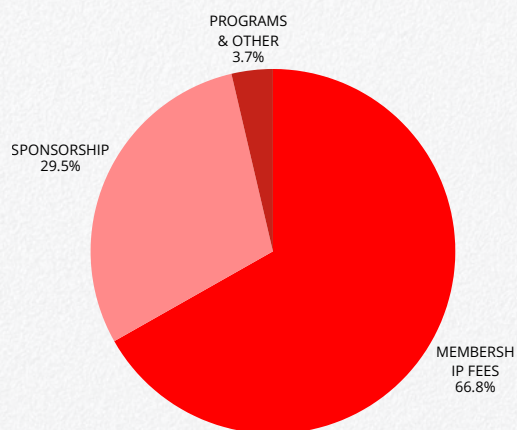

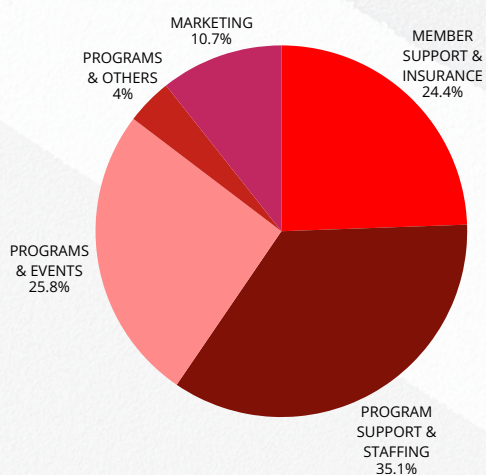
